Rules for the Taste of Laguna Food & Music Festival 2022

RULES:

- **No open flame is permitted on the Festival of Arts Grounds**
 - Sterno products are only allowed if accompanied by a fire extinguisher. If you are using Sterno products to warm food, you **MUST** have a fire extinguisher present at your booth.
- **No smoke or anything that can stain the white overhang**
- **No materials that may stain the grounds in any way. If you need to bring something to go underneath your space, please let us know ahead of time. Exhibitors will be charged a post-event 'excessive cleaning' fee of \$200 for any stains or marks left on the concrete surrounding your exhibit location.**
- **All garbage and trash must be placed inside waste receptacles and designated dumpsters (not on the ground in front of bins, parking lot, or left at your booth area). Exhibitors will be charged a post-event 'excessive cleaning' fee of \$200 for leaving trash at their booth site or outside dumpsters and trash receptacles.**

ALCOHOL:

Due to Orange County regulations, vendor booths may not distribute alcohol samples. All alcohol must be sold at designated bar areas. No alcohol may be served by anyone but designated bartenders. If these rules are broken at any time during the event, an exhibitor may be asked to leave the venue. Disregard for these rules may also jeopardize any future opportunities for participants at the Taste of Laguna.
